CASH FLOW COMMENTARY

As Clean Seas continues to increase the biomass of live fish to a mid term target of 5,000 tonnes there will be a continuing requirement for additional cash due to the sale lag time and the cost of carrying increasing volumes of inventory.

Clean Seas currently has 3,500 tonnes of biomass in the water and would expect to reach the 5,000 tonne level by April 2009. The company is actively working to more evenly match growth with sales requirements. This will take some pressure off cash requirements

Farming operations have a lag time between the cost of growing the product and the cash flow from the sale of the product. Kingfish farming requires a 16 month initial growing season and the product is then sold over a 12 month period.

Extended credit terms with the principle feed supplier to the company has resulted in the largest cash flows taking place in the periods when the least feed is being used. This is reflected at 1.2(e) other working capital in the cash flow statement.

1.9 in the cash flow statement reflects continuing expenditure on infrastructure to reduce fish growout costs. A dedicated harvest vessel was commissioned for service in September 2008.

Clean Seas has committed facilities of \$27.0 million in place with Rabobank Australia to facilitate this growth. This facility has been increased from \$20.8 million. The directors believe this facility will allow Clean Seas to fund the mid term inventory target of 5,000 tonnes.
